- Removal and reinstallation of existing decking boards as needed for utility disconnection and installation.

 with valves, seasonal drains, fittings, and UV protection sleeves as described in the

- Furnish and install new electrical panels, CT cabinets, ground fault monitors, marine utility pedestals, conduit, wire, cabling, and additional electric equipment as described.
